NUMBER OF WARDS

The City of Brandon is hereby divided into three (3) wards of substantially equal population.

WARD BOUNDARIES

The wards shall be described by setting for the certain street, avenue or boulevard designations or other landmarks that divide and border the wards. Any reference to street, avenue or boulevard below shall mean an imaginary line running down the approximate middle of each street, avenue or boulevard. The wards of the City of Brandon are as set forth below and the map thereof on file in the office of the Finance Officer. Any discrepancies shall be resolved by reference to the map rather than the physical descriptions set forth herein.

A.. WARD I

Ward I shall consists of all the land within the city limits lying west of the Big Sioux River and all the land within the city limits lying south, west and north of a line beginning at the intersection of the Big Sioux River and Holly Boulevard, east on Holly Boulevard to the intersection of Holly Boulevard and Main Avenue, south on Main Avenue to the intersection of Main Avenue and Aspen Boulevard, west on Aspen Boulevard to the intersection of Aspen Boulevard and Sioux Boulevard, south on Sioux Boulevard to the intersection of Sioux Boulevard and Splitrock Boulevard, south on Splitrock Boulevard to the city limit line.

B. Ward II

Ward II shall consist of all the land within the city limits lying west, north and east of a line beginning at the intersection of I-90 and Splitrock Boulevard, south on Splitrock Boulevard to the south intersection of Splitrock Boulevard and Aspen Boulevard, west on Aspen Boulevard to the intersection of Aspen Boulevard and Main Avenue, north on Main Avenue to the intersection of Main Avenue and Holly Boulevard, west on Holly Boulevard to the intersection of Holly Boulevard and the Big Sioux River, following the west city limit line, (east of the Big Sioux River), north to the intersection of 481st Avenue and Hemlock Boulevard.

C. Ward III

Ward III shall consist of all the land within the city limits lying east and south of a line beginning at the intersection of I-90 and Splitrock Boulevard, south on Splitrock Boulevard to the south intersection of Splitrock Boulevard and Aspen Boulevard, west on Aspen Boulevard to the intersection of Aspen Boulevard and Sioux Boulevard, south on Sioux Boulevard to the intersection of Sioux Boulevard and Splitrock Boulevard, south on Splitrock Boulevard to the city limit line.
